## 5. Old Business

a. Location discussion – Chairman Gionet and L. Sweet continue to work with the town planner and the Planning and Zoning Commission on behalf of the Farmers' Market Committee to implement a zone regulation change to section 10.27.2.g "to allow no more than 30% of all vendors, up to a maximum of 5 food trucks, at each Farmers' Market event...".

Motion made by L. Sweet second by T. Wilson to continue to pursue moving the Farmers' Market location from the Lisbon Meadows Barn to the Newent Meeting House Greens.

VOTE: UNANIMOUS, MOTION CARRIED

Chairman Gionet and L. Sweet have discussed this change in location with the Lisbon Historical Society and have received their approval. They have also met with T. Sparkman, First Selectman to review with the Board of Selectmen for permission to present the proposal to the Planning and Zoning Committee. L. Sweet presented this request to the Planning and Zoning Committee on 2/6/2024 and found that the major concern would be for parking. A plan for this as well as a site map will be presented at the next meeting. Additional conversation regarding storage of supplies and if they can be moved from the Barn to closer to the Meeting House Green.

b. Signs

Motion made by E. Gionet second by L. Sweet to approve spending up to \$200.00 for signs advertising the new location and adding Jewett City Savings Bank as a sponsor.
