b. Grants/funding/sponsorships

A \$1,200 request for Face Painting sponsorship to Charter Oak FCU was submitted on 3/25/24. No response to the request has been received.

A \$1,200 solicitation for sponsorship has been made to Dime Bank for Face Painting or Family Entertainment. Awaiting response.

A response from the Department of Agriculture Grant Application is anticipated on 5/1/2024. Until the status of the Grant money is known, action to expend funds for additional radio advertising, garbage bins, signs, tent and table covers is on hold.

c. SNAP

The process to register into the SNAP program is a multi-step procedure that will take some time. It was the decision of the Committee to begin the leg work and proceed with the process even if it will not be completed in time for the Market this year. It will set the foundation for next year.
